Countdown Is On: More than 85% complete!

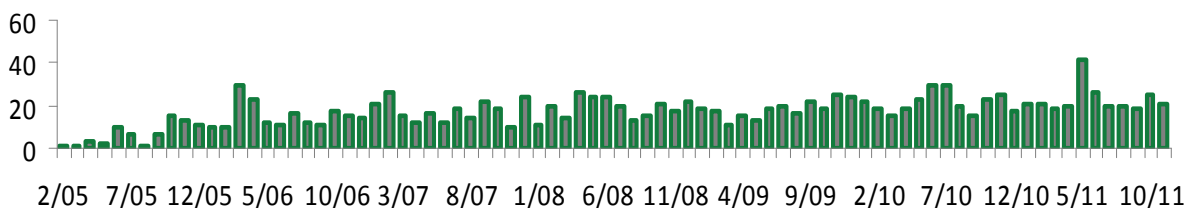
Paramedics in Los Angeles and Orange Counties have made FAST-MAG one of the most important stroke studies ever. With over 1,400 patients enrolled, we are now counting down the last 15%. To help the study end as early as possible, it is vital to quickly identify possible stroke patients, call the enrolling MD while **still on scene**, and follow the protocol for consent procedures and starting study drug. The sooner we get to the final patient, the faster will we will know if magnesium helps stroke patients have better outcomes.

FAST-MAG QUICK GUIDE

1. Identify potential stroke patient.
2. Perform mLAPSS exam (goldenrod form).
3. If LAPSS exam positive, determine hospital destination as usual. Inform the MICN you have a *possible FAST-MAG patient*. Locate the hospital specific consent.
4. Introduce the study to the patient, or legally authorized representative. The enrolling MD will explain the study and answer all questions.
5. Call the FAST-MAG enrolling MD.

If you are unable to speak to an enrolling MD, transport as usual

**MICNs and base hospital physicians may NOT
order the study drug to be started**

Do NOT open the drug kit until the enrolling MD tells you to do so

6. After the FAST-MAG enrolling MD confirms that the patient meets criteria and has obtained informed consent, have person who spoke with the doctor (patient or legally authorized representative) sign the green pages of the consent. Inform the enrolling MD after the pages are signed.
7. When the enrolling MD tells you to do so, open the drug kit. Remove the 50ml bag with the **GREEN** Field Dose label and the special rate-limiting tubing.
8. After priming, open the green slide and hang the bag *at least* 3 ft above the patient.

**Must begin field dose before crossing the ED threshold **
9. Complete transport of patient to hospital.
10. When you arrive at the hospital, complete the back page of the LAPSS form.
11. Give the completed LAPSS form, all pages of the signed consent, the 250 ml hospital dose (**YELLOW** label) and a legible copy of the paramedic run sheet to the ED RN.
